### **Summary of Discussion**

- 1. Welcome and Introductions : Alternate Chair, Bill Greenaway
- 2. Opening prayer by GA
- 3. Day One February 1st, 2012: T&C Compliance Plan Review

Chair Bill Greenaway started the meeting with requests from members for the following two actions.

Action Item: EN/MD to put HATCH Environmental Compliance Plan Report on website.

Action Item: MECC members to complete the self-evaluation which has been distributed. This is in compliance with the evaluation of MECC.

Presentation: by EN on EA Compliance Plan.

EN explained the purpose of the presentation was to get input from MECC for prioritization of reports to assist in setting up the work plan for EWG.

Action Item: Add to agenda for Feb 2 meeting/or future meeting to review Terms of Reference of MECC

At this point Chair Rob Galloway joined the meeting.

EN continued with Presentation #2 Heritage Resources of Compliance Plan

RG indicated that there is a need to record the Cree names and places. This needs to be presented in a form that can meet T&C 2c (map, historical text, and the Cultural Centre. EN indicated that the data for T&C 2a has been collected and now work is progressing to form the historical text.

RE: Condition 2b, EN suggests that EWG should have a good idea of issues and work required to bring to MECC

GA asked if there is a report of cultural sites that would show itemized areas.

MD indicated that the report is registered with Ministry of Culture and will be on web site.

EN asked what form would MECC like this to be in?

JS asked do we want it to be as an on-going or final report?

Action Item: EN to request for presentation to MECC from John Pollack on current activities (get details on where are the "no-go "heritage sites).

EN continued presentation on 2c ... this is an extension of work in 2a. The cultural working group is planning workshops for Feb/March and MECC will be invited.

JR what is happening for TTN with Cultural Heritage?

EN indicated that TTN needs to be brought on any plans for a Cultral centre that will fulfill condition 2b..

JR raised a concern about the need to include the Ojibway perspective with TTN.

Action Item: EWG to come back with a plan for the cultural heritage building, or info centre, is it possible to have more than 1 site (this plan would be working towards an answer).

Break was taken and discussion held RG, EN, and MD on how to move forward in time left.

#### EN led the group to T&C 19

RG indicated there is a plan in place (DB contractors) and MECC has observed in person

Action Item: EWG to review plan and bring to MECC by after T&C 4 reports have been presented.

#### **Discussion:**

JS questioned about the turbidity curtains

EN indicated the dealing with the curtains are beyond the compliance plan because the curtains are not considered domestic waste, but are being satisfactorily dealt with. EWG is responsible for the EA T&Cs, and the Terms and Conditions associated with any permits and approvals.

BG question- is an audit needed?

RG should not assume review is all inclusive.

BG how will MECC know when T&C met (audits, report)?

EN indicated that the EWG should be working with MECC members to understand each EA T&C and to bring any concerns associated with the fulfillment of the T&Cs to the EWG during its reviews of the reports that are meant to fulfill the TCs.

JT indicated MECC members need assistance
